ENTREPRENEURSHIP - COOPERATION - SUCCESS

This year, a very important event in the Polish economic life took place. In September, the global index provider FTSE Russell announced the results of the annual country classification in terms of development. Poland was reclassified from the country belonging to the emerging markets to the developed ones. This will take place in September 2018. This decision means that Poland belongs now to the group of 25 markets being the most developed ones which include, among other things, Germany, France, Japan, Australia and the United States. This is a form of appreciation of development of the Polish economy and our capital market and also a very important step in its growth. The reason is that Poland has all the advantages of developed markets, such as safety of trading, post-transactional services and developed infrastructure. In addition, the dynamic growth of the Polish economy is a good argument for investing in our market by global investors.

This distinction is not simply out of courtesy but a factual appreciation of efforts of Polish entrepreneurs who, for almost 30 years of the free market operating in Poland, have been trying to invest in their businesses despite numerous obstacles. Sometimes we are not aware of our achievements and potential for development. It is the fact that our private businessmen are the real driving force of development of the Polish economy. In general, their contribution in this process is twice as much as the public sector's one.

It is worth noting that each year over 2 million Polish entrepreneurs invest almost PLN 140 bn when employing at the same time 6 million people. In Poland, 70% of the whole income per capita originate from salaries paid by private firms. The private business in Poland contributes already 85% to GDP, generating PLN 260 bn of taxes to the budget. Since 1990, our GDP increased four times and export – ten times. Poland tremendously improved the quality of life of its citizens. We systematically reach European standards. The fact that qualified persons come to work in Poland not only from Ukraine or Byelorussia but from other EU states also proves that we have become more and more attractive labour market.

We are glad to note the government's efforts to improve business conditions and ensure the Polish entrepreneurs' rights resulting from the Constitution for Business and the Strategy for Responsible Development. Nevertheless, there are still many issues waiting to be solved. Undoubtedly, inconsistent and various interpretations are not of any help in developing business. Similarly, clerical indolence and lack of decisions to be made do not have any positive influence on creating business-related plans. However, a Polish entrepreneur can do it! Therefore, we look forward to quickly adopt solutions serving the purpose of developing Polish enterprises and facilitating their operations and also simplifying, limiting and stabilising legislation in this respect. Then, we, Polish entrepreneurs will have no choice but to create the land flowing with milk and honey. It remains to be seen whether this will come true. I am, however, convinced that in the upcoming years, the Polish business will have

continuously better development conditions which consequently will result in a further significant growth of the Polish economy and members of the European Business Club Poland and laureates of this and future editions will have a measurable contribution to it.

We often analyse whether after 28 years of functioning in the market economy, we achieved as much as we could for our businesses to smoothly develop, to ensure a relevant size of our budgets and our employees be appropriately remunerated for their work. We are fairly critical about ourselves, however, when we see how the worldwide business and various opinion-formers welcome our efforts, we can claim that it is not that bad, on the contrary – everything is in order. I wish all of you continued success in smooth expansion of your businesses.

I would like to thank all the awardees for their efforts in their daily work and for serving as an example for others to emulate despite any adversities which they face. I would also like to thank the Managing Board of the Association, the Chapter of the Awards Committee headed by Professor Elżbieta Mączyńska and also those involved in organising our project for their input, friendly advice and assistance.

I should like to take this opportunity to invite entrepreneurs as well as all individuals and organisations concerned to cooperate with the European Business Club Poland. When acting together with us, you will encounter new opportunities for new business contacts, exchanging views about any Polish and European economy issues and participating in the exchange of economic, scientific and legislative information.

EUROPEAN BUSINESS CLUB AWARDS - HUMANISM, HOLISM AND SOCIAL INCLUSION

The world of business is full of various rankings and awards. They adopt diversified criteria. What distinguishes the European Business Club Awards from others is their focus on humanism, holism and social inclusion, i.e. counteracting social exclusion and wasting development potential, including the most precious one – human intelligence and creativity.

These issues are becoming of substantial importance in conditions of the ongoing civilisation breakthrough resulting from the digital revolution. Although this breakthrough reflected by, among other things, development of the digital economy, including development of the Internet of Things (IoT), or development of robotization, gives rise to expansion creating at the same time development opportunities, it also entails the risk, including the risk of progressive dehumanisation. Albert Einstein warned us against it already in 1946, in his letter addressed to the American and German intellectualist and physician - Otton Juliusburger in which he wrote: "I am convinced that the horrifying fall of morals we are witnessing these days results from mechanisation and dehumanisation of our life – destructive by-products of scientific and technical mentality. Nostra Culpa!". Despite the passage of many years, this opinion has not lost its relevance, only that mechanisation has now the form of "Internetization" and robotization.

The modern world with its numerous dysfunctions, asymmetries and globally violated balance, cybercrime and geo-political problems confirms the rightness of Einstein's warnings. Nostra Culpa /our fault/ is the allegation and caution. At the same time, it shows the necessity of adopting a holistic and universal approach to technological and economic changes and also their consequences, the view through the improvement of living conditions and social relations. Holism understood in this manner is the foundation of which the concept of the European Business Club awards is based on.

I have the honour to chair the Chapter of this competition. Although the Chapter operates under the brand of the European Business Club, its verdicts are not limited only to business circles. The guiding principle of the Chapter's social work is interdisciplinarity and complexity of the criteria of selecting and assessing candidates for awards. Awards are thus granted to individuals and institutions acting not only in the business world but also in the world of culture, science, education, sports and others, the areas contributing to harmonious social and economic development.

The source of inspiration for the holistic approach of the Chapter of the European Business Club Awards is life itself, social and economic phenomena which prove that lack of the holistic approach and fragmented activities and decisions become the constraint to any development. 

Ladies and Gentlemen,

Honourable Guests of the European Business Club Poland Gala,

We have gathered here to honour significant achievements and accomplishments of our Laureate in the social, political and primarily - economic activities to date. We would also like to stress the extraordinary personality traits of Mateusz Morawiecki, his empathy for willingness to solve daily social and economic problems and also his determination to improve the situation in Poland in terms of domestic and international conditions.

Mateusz Morawiecki graduated from three Polish universities, and he also studied at three universities abroad. He graduated from the University in Wrocław, completed a demanding program of studies at the Wrocław University of Technology implemented in cooperation with the Central Connecticut State University and he was awarded the MBA degree from the Wrocław University of Economics. He is also a graduate of outstanding foreign universities where he studied European law and the business integration economics at the University of Hamburg, enriched his knowledge at one of the oldest Swiss universities – the prestigious University of Basel, and he also studied in the United States - at the Kellogg School of Management at Northwestern University. Our Laureate efficiently uses the acquired comprehensive knowledge in achieving, on a daily basis, his ambitious goals.

The managerial experience of Mateusz Morawiecki is equally impressive; allow me to mention his apprenticeship at Deutsche Bundesbank or the elementary example

of his carrier at Bank Zachodni where he was the advisor to the management board and after the merger of Bank Zachodni with Wielkopolski Bank Kredytowy, he became a member of the management board where, after the change of the owner in 2007, he was the President until 2015. Our Laureate was involved in local self-government activities, in 1998-2002 he was a member of the Dolnośląskie Provincial Assembly, and he also participated in the negotiations on Poland's accession to the European Union. He was also the honorary consul of the Republic of Ireland in Poland.

As a person familiar with current problems of the banking system during the crisis after the collapse of the bank Lehman Brothers, Mr Morawiecki assumed the joint responsibility for the financial stability in Poland and started to actively participate in the Economic Advisory Council to the Prime Minister. According to unofficial reports, it is thanks to him and his role of the "economic messenger" that significant information was exchanged between the government and the largest opposition party – the Law and Justice Party – and its leader, Prime Minister Jarosław Kaczyński, Doctor of Laws, with respect to efforts to maintain financial stability during the widespread financial crisis in Europe and worldwide. Today the measurable effect of this cooperation is the "Strategy for responsible development" commonly known as the "Morawiecki's plan" which is becoming the strategy for developing the whole Polish economy at national level.

During the second year of performing the function of Deputy Prime Minister, the Minister of Development and Finance in the united right wing government, Mateusz Morawiecki "forced" the biggest international rating agencies to change their restrictive approach to Poland which resulted in the significant increase in GDP growth forecasts in Poland. Other significant achievements of Prime Minister Mateusz Morawiecki in the field of economy include, among other things, preparing the Constitution for Business, the repolonization of banks, lowering the age of retirement, increasing the income tax threshold, promoting start-ups, developing the electro-mobility and many others.

In the years of his youth, Mateusz Morawiecki was a member of Solidarność Walcząca and during his studies – of the Independent Students' Association [Polish: NZS], and participated in students' strikes. Having been intimidated and persecuted by the security services of the People's Republic of Poland, the young Morawiecki did neither get scared nor was panicked by the threat of taking his life. It was then that he started to become independent and attached to the idea of civil and economic freedom. These events seem to shape the indomitable and state-oriented approach of Mateusz Morawiecki manifested in daily efforts to ensure the principles of fair competition in market economy to be followed.

No economist in Poland to date has exercised effective control ensuring such huge proceeds to the state budget. Closing the loopholes in the VAT system resulting in billions of Polish zlotys for the Polish state budget is undoubtedly the greatest achievement of our Laureate.

Summing up, since Mateusz Morawiecki is reliable, effective and independent in his activities, he gains trust of the Polish people.

The European Business Club Poland's approach to business-related matters is holistic as it recognises their importance for entrepreneurship, culture, science, media and their whole surrounding. Such complexity means the synergy of economic activity with all other fields resulting in the comprehensive development of the whole society, humanity and the improvement of living standards. The Association, when carrying out its activities, adheres to the principles adopted by it as well as the system of values and ideals recognising them as imperative and timeless. They are: culture, ethos, morals, ethics and social solidarity. These values are specifically taken into consideration by the European Business Club Poland when awarding prizes being their personification.

The main award of the European Business Club Poland VICTORIA EUROPAE 2017 EUROPEAN VICTORY is granted for remarkable achievements resulting in enhancing Poland's prestige worldwide. In 2017, this award was presented to Mateusz Morawiecki, Deputy Prime Minister, Minister of Development and Finance in recognition of his outstanding merits and achievements in conditions for the development of the Polish economy and raising its rank on the international arena.

Due to the extremely wide spectrum of issues, activities and impacts being addressed, Deputy

Prime Minister, Minister of Development and Finance Mateusz Morawiecki has a real influence on developing the Polish economy, its competitiveness and removing any obstacles in its functioning. By his decisions he creates the conditions for business activities being carried out by Polish entrepreneurs, safeguards the guarantee of economic freedom promised in the Constitution of the Republic of Poland and in addition, he also determines the scope of partnership between the public administration and entrepreneurs.

Mateusz Morawiecki regularly and willingly meets entrepreneurs, listens to them and holds a dialogue with them. He also participates in international, bilateral and multilateral projects during which he effectively encourages investors to cooperate with our country and presents solutions adopted in Poland. In international relations, he actively presents the Polish national interest and seeks the Polish economy interests to be fulfilled.

Two important nationwide documents were prepared under the direction of the Deputy Prime Minister, Minister of Development and Finance:

- The Constitution for Business;
- The Strategy for the Responsible Development until 2020 (with the perspective until 2030).







The Constitution for Business is a long-awaited document. Its purpose was to guarantee the entrepreneurs' rights. It stipulates, among other things, the appointment of the entrepreneurs' spokesman for which the European Business Club Poland called already in 2013 and which was specified in the bill draft prepared by one of the members of the Management Board of our Association. Although the bill draft was submitted to the representatives of the Deputies' Clubs in the Lower House, they did not support it then. Now, there is a chance of introducing it, and we do hope for it.

One of the basic aspects important for every entrepreneur is the transparency of law and interpretations of regulations, and thus, consequently, certainty of law. Certainty of law is the primary ally for entrepreneurs as it allows them to make key decisions related both to their ongoing businesses and the strategy of their development. Certainty of law produces measurable effects by, for instance, reducing costs of legal assistance or costs of time-consuming court proceedings. The reference to the famous "Wilczek's Act" according to which whatever is not expressly forbidden, is allowed is also related to the aforementioned certainty of law. Our approaches to the principle of "tacit consent of the authority" or interpreting any ambiguities to the entrepreneur's benefit are alike as well.

We are also optimistic about the proposal of applying, by authorities, penalties adequate to misconducts. It undoubtedly creates a sense of justice and serves the purpose of strengthening positive relations between the country and entrepreneurs. We also hope that it will eliminate well-known cases in which minor offences (e.g. an error of few groszes [00/100] on an invoice) were subject to the penalty exceeding many times losses, if any, incurred by the State Treasury and being disproportionately high in relation to the fault being factually caused.

It is also justified to appoint a joint government-entrepreneurs commission as the permanent forum for discussions and cooperation between the ministries and the entrepreneurs' representatives aiming at, among other things, drawing up opinions on legal acts of great importance for business activities and working out mutual solutions. The European Business Club Poland supports the suggestion of Professor Elżbieta Mączyńska, President of the Polish Economic Society, to expand the composition of such commission also by the representatives of non-governmental institutions.

Placing emphasis on establishing partnership relations between the state and entrepreneurs based on mutual trust and "friendly neutrality" is of great importance. Based on the assumptions presented in the Constitution for Business, one may conclude that the manner of perceiving entrepreneurs has been changed – they have been finally recognised as solid foundations for building welfare and development of the Polish society.

The second document The Strategy for the Responsible Development until 2020 (with the per-





spective until 2030) is a key document with respect to the medium- and long-term economic policy. This strategy is already in the process of being implemented through specific activities and projects which were undertaken already last year by the Government of the Republic of Poland and institutions subordinated to it, within the framework of changing the development paradigm for Poland. Increasing the Polish capital share in banking sector, a new quality of export policy, the package of facilities for firms, the effective unification of institutions responsible for development or the ability to acquire technologically advanced Polish and foreign greenfield--related investments constitute only a few examples of projects completed so far. They prove that the Strategy is effective, but first of all they show a powerful and positive development potential in the Polish economy and Polish entrepreneurship. A glorious vision of development connected with economic pragmatism aiming at strengthening and modernising the Polish economy and significant increase of the competitiveness of products and services offered by Polish firms has been worked out. It will be supported by new developing instruments created within the framework of the Strategy (financing products and support programmes) for such areas of special priority as: international expansion, industries of the future, development of small- and medium-sized enterprises, public and private partnership, investment partnership with local self-governing authorities, development of the venture capital market in Poland or territorially sustainable development, with particular regard to special economic zones and investments in areas neglected to date.



The strategy is oriented at the responsible and joint and several development, and it aims at emerging entrepreneurship, inventiveness and productiveness. Coherence among comprehensive social programmes, designation of several tens of billions of Polish zlotys each year for creating equal social opportunities and economic development and ensuring the financing for both economic and social programmes is a key to success of the Strategy. Although there is a natural competition between goals of social and development policies, the Strategy assumes that reducing such competition will be possible as a result of introducing the programme of eliminating loopholes in tax regime. It is a sine qua non condition for development while maintaining the budget sustainability and stability of solidarity

schemes.

The Strategy for the Responsible Development creates the space for great new opportunities to be used in economic processes. At the same time, it gives hope for developing all social classes. It creates mechanisms of effective cooperation inside industries and among various sectors of the national economy. It balances the concern on enhancing competitiveness of enterprises and solidarity schemes. Ongoing competition and cooperation in various sectoral areas creates new prospects for development. Merging the world of science, research and implementation with business environments will allow a new quality and higher profitability of the whole economy to be achieved.

Mateusz Morawiecki was born on 20 June 1968 in Wrocław. He is a Polish manager, banker and politician.

On 11 December 2017 he was appointed to the position of the Prime Minister, the Minister of Development and Finance.

From 29 September 2016 to 11 December 2017, he was the Deputy Prime Minister and the Minister of Development and Finance. From 16 November 2015 to 29 September 2016 he was the Deputy Prime Minister and the Minister of Development.

He was awarded the MBA degree from the Wrocław University of Economics. Co-author of the handbook on EU laws and economics of economic integration. In the years 1998–2001, he was a member of supervisory boards of the Agency for Industrial Development (ARP) and Zakład Energetyczny Wałbrzych. He was also a member of the Dolnośląskie Provincial Assembly of the 1st term. In 1998, he was the Deputy to the Director of the Accession Negotiation Department at the European Integration Committee, and he was also a member of the team negotiating Poland's accession to the European Union (Banking and Finance). Dear Sirs.

It is with pleasure that I welcomed the information about the prize VICTORIA EUROPAE awarded to me. It is a great honour to be awarded by such a respectable board. It is therefore the more regrettable that due to my pre-planned official duties, I am not in position to collect it in person. I would like to sincerely thank you for recognising the work we perform at the Ministry of Development and Finance. To me this award is the award for competencies, involvement and effectiveness of those who create the Polish brand and try to convince Europe and the whole world to it. This brand is the Polish entrepreneurship, and it is the Polish entrepreneurship that deserves to receive this award.

Without you, the entrepreneurs, we would not enjoy the fact that engines of the Polish economy are put on full speed. In the first half of 2017, Poland's GBP growth was 4 per cent, and we have reasonable grounds to believe that we will maintain this rate of 4 per cent or even more at the end of this year as well. Since we attach a great importance to the quality of development, we place emphasis on strengthening its investment pillar. I am convinced that results of investments in the third quarter will positively surprise the market. We act methodically – we are eliminating loopholes in the tax system, and now it is the time to set investments in motion and prepare better laws for entrepreneurs. Our country has ceased to belong to the emerging market, and it has entered the group of developed countries.

The first goal we set to be attained when coming to power was to change the approach to the economy and entrepreneurs. We placed the accent on building a strong country which is a serious partner for the whole business. The first step was preparing the Plan for the Responsible Development and then – adopting the Strategy for the Responsible Development by the Council of Ministers. Many of the entrepreneurial initiatives and projects described in the Strategy have already been introduced, and the further ones are in the process of being implemented.

They include three packages of facilities for firms, especially the smallest ones, and also the Constitution for Business, the new pro-freedom act which will replace the old Act on Freedom of Economic Activity. Since one of the competition advantages of our economy may be a good commercial law, the Constitution for Business is an absolute priority for me. We expect this document to be adopted by the Council of Ministers within two or three weeks.

The first package of the "100 changes for firms" prepared before the Constitution for Business, has been implemented in almost 90 per cent. According to our calculations, one good change for business is introduced every four days. We introduced, among other things, the rule according to which an entrepreneur may be inspected only once with respect to one case; we raised the limit of the value of litigation examined in simplified proceedings from PLN 10 thousand to 20 thousand; we removed a number of absurd situations and minor inconveniences which make the running of firms difficult. As from the beginning of the next year the Register of Public Law Receivables which will allow entrepreneurs to check their potential contracting parties' tax arrears towards the government, will start to operate. These are only some examples. There are many more facilities, and we are working on further ones.

The subject of ongoing consultations and settlements is, for instance, the law which will allow entrepreneurs to save almost PLN 4 bn within a decade. The entrepreneur will be entitled to recognise the remuneration paid to his spouse as revenue earning costs. It will also be possible to settle, on a one-off basis, the loss up to PLN 5 million. We unambiguously clear any vagueness in the regulations which impede operations of companies with limited liability. We are also working on solutions making the succession of family firms easier and the new form of economic activity – a simple joint stock company dedicated for young innovative firms.

The responsible state should also care for their citizens to ensure that they have equal opportunities on the market. The assumption that the state should cease to be weak against the strong and strong against the weak is one of the priorities of the government to be recognised. We have taken on the scourge of swindlers extorting VAT. After years of negligence in this respect, revenues on this account have started to increase, and they are very likely to exceed PLN 143 bn this year.

We also fight for a fair competition in the European Union. It is with disquiet that we note that some EU states opt for commercial protectionism, and unfortunately, they do not always play fair. For this reason, the support for our foreign investors and exporters cannot be limited only to financial incentives. The state's intervention in the highest decision-making bodies is necessary.

We are building the state which is a strong partner for the whole business. I am fully convinced that all the activities we undertake make operations and development of Polish firms much easier. Stable and safe economic environment of Poland is also attractive for foreign entrepreneurs who are very welcomed in our country, but at the same time we expect a good quality in investments from them.

Finally, there is a magic word: trust. Should there be mutual trust between the state and business, I am very confident about the condition of Poland's economy. The most powerful worldwide economies were built on trust. Therefore, let me recognise the today's award as an expression of confidence. I would like, already today, to nominate a candidate for next year's award. The candidate will be the entrepreneurs.

Beata Drzazga is the founder and owner of the biggest all-Polish medical centres network Beta-Med SA specialising in providing the long-term care services.

BetaMed SA has been on the market for 15 years, employs approximately 3 thousand people and operates through 84 affiliates located in 11 provinces. The company she runs is the biggest medical firm in Poland providing home and inpatient care for the chronically ill and the elderly. It is an innovative firm which places emphasis on activation of the elderly, the top quality of medical care and empathy to others.

"I took – for safety reasons – unpaid leave from the hospital I worked in, and I founded my own company. I was encouraged, moreover, to do so by everyone – the nursing board and politicians. I started from the ozone therapy which is the set of treatments for persons with sight problems (after the treatment their sight was brighter and sharper). One year after, I signed the contract for the long-term care services. As a nurse, already from the very beginning I knew that my mission was to care for the ill – says Beata Drzazga."The beginnings were not easy. I had to learn how to place offers to the National Health Fund (NFZ), get used to inspections and thousands of documents to be filled in. Obstinacy, passion ... results"

The firm renders the home care services covering long-term nursing care and mechanical ventila-

tion for over 5 thousand patients within the framework of the contract with the National Health Fund. The inpatient care services are provided at the Clinic BetaMed Medical Active Care in Chorzów of which mission is to provide the complex medical assistance to patients of any age.

Within the framework of BetaMed MAC the following facilities operate and services are available:

- Nursing Home (within the framework of the contract with the National Health Fund) – services in the scope of treatment, rehabilitation, nursing and psychotherapy, 24-hour medical care;
- Private daily and 24-hour stays for the elderly and disabled who need emergency care and wish to spend time actively in the company of people in the similar stage of life;
- Rehabilitation for persons of any age (within the framework of the contract with the National Health Fund and on a commercial basis) a wide range of rehabilitation treatments covering physiotherapy, kinesiotherapy, cryotherapy and hydrotherapy;
- Nursing Home for Children, Teenagers and Adults being Mechanically Ventilated (within the framework of the contract with the National Health Fund) 24-hour stays for patients with respiratory failures who do not require hospitalisation in intensive care units but require a permanent respiratory therapy with the use of a respirator device;

- Nursing stays for patients being mechanically ventilated (commercial services) – stays with mechanical ventilation therapy and complex treatment, rehabilitation, nursing and health care services;
- Specialist clinics commercial services rendered by specialists in cardiology, gynaecology, diabetology, laryngology, neurology, ophthalmology, orthopaedics and the imaging diagnostics laboratory (ultrasonography and

X-ray);

In addition, the Clinic is a place where healthand education-related meetings and workshops, and also theatrical performances, dancing parties and artistic performances addressed both to patients and local community are organised.

In 2016, the medical centre BetaMed based in Chorzów opened its branch in Las Vegas – "Beta-Med International". "For the time being I am get-



ting familiar with the American market and its demand. I wonder whether I should focus on the home, social, specialist, nursing or rehabilitation care services, or all of them in one package" – explained Beata Drzazga who was honoured, for the first time anywhere in the world, the title of the "Business Ambassador of Nevada" for cooperation, merits and promoting the State of Nevada. Governor of Nevada Brian Sandoval justified that "Beata is a very sociable, smart person, and she can serve as a great model for other businesswomen. For this reason, we came to the conclusion that it would be really great if she agreed to become the business ambassador of Nevada. She is very precious to us".

The firm "BetaMed International" which was established in Las Vegas is the product of cooperation within the framework of economic missions Poland–Nevada. "The cooperation between Beta-Med and firms operating in Nevada is very good, and I believe that it will remain like this" – says

the Governor of Nevada, and he also stresses that there are some small-sized Polish entrepreneurs in Nevada who are doing quite well in the US. He stressed: "Beata could serve as an example to them, just like she can serve as an example in Poland".

Apart from the fact that Beata Drzazga is the owner of BetaMed, she is also the director of the US-Poland Chamber of Commerce of the State of Nevada in Poland. Lidia Staroń – independent Senator of the Republic of Poland from the electoral constituency No. 86 (OKW Olsztyn). She received the mandate having been designated from her election committee "Lidia Staroń – always taking the side with people". In the electoral competition, she overwhelmingly won with counter-candidates from all other political options. She is the only parliamentarian in Poland who was elected only by voters without any support from political formations.

Deputy to the Lower House of the Parliament of the Republic of Poland [Polish: Sejm] of the 5^{th} , 6^{th} and 7^{th} term.

Civil engineer. Before she became a parliamentarian, she had been an entrepreneur, the president of the trading and service company, and she was also engaged in managing real estate.

For years she has been active in the fight against lawlessness, cliques and coteries. In the fights with dishonest law enforcement officers, clerks or officers hurting people, she addresses problems experienced by Polish entrepreneurs. She always takes side with victims, both as a senator and also in the programme "State in the State".

Being very well acquainted with problems and ills of entrepreneurs, during the 4th term of office of the Polish Parliament she proposed to introduce entrepreneur-friendly provisions of law, which assumed, among other things, faster registration of companies, extending electronic access to data in the National Court Register or introducing the possibility of entering *ex officio* a tax identification number [*Polish: NIP*] by courts. She also succeeded in gaining the strengthened legal protection by, among other things, the complaint about violating the party's right to examine their case without undue delay or the new type of civil proceedings – class actions.

As a deputy of the 6th term of office, she also solved the problem of imposing surcharges other than a margin by hypermarkets on producers and suppliers of products. It was after her intervention when prosecutors initiated proceedings on the part of such suppliers – against dishonest retail networks.

Apart from initiatives related to introducing new laws, Lidia Staroń undertakes numerous interventions in individual and group problems of entrepreneurs. She holds also negotiations with banks and institutions for entrepreneurs who lost their financial liquidity, helps those who became victims of usurers, negotiates housing issues with local self-governing units, helps to recover movables and supports entrepreneurs in civil and criminal cases related to their businesses, e.g. in proceedings for payments from dishonest contracting parties.







Lidia Staroń succeeded in assisting the entrepreneur whose all businesses was ruined due to the expert's false opinion. On the basis of this and similar cases, this deputy amended the law (the Code of Criminal Procedure) as a result of which persons who considered themselves wronged by any document-related crimes (false opinions, documents, false testimonies, etc.) acquired more rights to be able to seek justice. Consequently, as from 2013, any person who submitted the notification about any crime, being no victim, may file a complaint about the decision refusing to institute investigation or its discontinuance.

Her success in assisting the entrepreneur from Nidzica caused that – for the first time in Poland – the court enforcement officer, who together with the expert unlawfully sold the whole entrepreneur's property for next to nothing, was finally and validly sentenced to absolute imprisonment.

In another case, as a result of the court enforcement officer's and court's negligence, the real property which the entrepreneur bought at the public judicial auction for almost half a million Polish zlotys, was – during the enforcement proceedings – .. sold once again. The entrepreneur unsuccessfully fought for the recovery of money or this property. Only after Senator Staroń's intervention, he finally became the owner of the real property which he had bought ... 8 years before.

The property was also recovered by a self-employed nurse –a mother of four children – who had been taken, by a court enforcement officer, a newly purchased second-hand car she had bought to visit her patients. This car was burdened with debts of ... its first owner. Only Lidia Staroń's decisive intervention allowed for recovering this car and carrying on a safe business.

These are only a few stories which ended up with a positive outcome only because of Lidia Staroń's efforts. Ms Senator recovers for people real properties and movables taken from them illegally, fights for families and abused children, victims of crime but first of all – for the good law – the law friendly for people.

She is a community activist whose assistance is free of charge. She organises nation-wide social campaigns "The whole Poland talks to children", "Strop drinking, start living", "Mum, please have a check-up" and "The legal GPS" (the law learning programme at high schools).

For years she has been a sponsor of prizes and honorary patron of the competition organised for high school students "My idea for applying exact sciences to solving daily life problems" organised by the Association for Children and Particularly Talented Young People in Olsztyn.

For many years, she has been the patron of many charity organisations, including the Foundation "I have a dream" which makes dreams of many ill children come true.

Maciej Kot made his debut in the representation in 2006. He climbed a podium result in the World Cup on 11 December 2016 in Lillehammer (ranked second). The first place in the World Cup on 11 February 2017 in Sapporo. The team gold (2017) and bronze (2013) medallist in world championship. The individual Junior World Vi-

ce-champion in 2009, the double team bronze medallist of junior world championship, the double individual and team medallist of the Winter Universiade in 2011. The winner of the Summer Grand Prix 2016, the third player in the general classification of the Summer Continental World Cup 2015. The multiple medallist of the Polish Championship, including the double individual champion in 2013 and 2016. His personal best is 244.5 metres during Vikersundbakken in Vikersund on 18 March 2017.




Dawid Kubacki - nickname: Mustaf. In the World Cup, he made his debut on 16 January 2009 in Zakopane (49th place). The team gold (Lahti 2017) and bronze (Val di Fiemme 2013) medallist in world championship, Olympian (Sochi). The second player in the general classification of the Summer Continental World Cup 2015. The summer Polish champion in 2013 and 2015, and also the multiple medallist in Polish championship. The winner of the Summer Grand Prix in Wisła and Hinterzarten in 2015. The style of his ski jumps is characterised by a high parable of jump. His personal best is 232.0 metres at Vikersundbakken in Vikersund (19 March 2017). Dawid Kubacki is the first ski jumper of the 21st century who won all the competitions of the Summer Grand Prix in one season in which he

participated. Maciej Kot was close to this achievement a year ago.

Kamil Wiktor Stoch made his debut in the representation in 2001. He achieved his first podium result in the World Cup on 23 January 2011 in Zakopane (the 1st place). In the World Cup, he won in 22 competitions and climbed the podium 44 times. The double Olympic medallist in 2014, the individual world champion in 2013, the team world champion in 2017, the double team bronze medallist in world championship (in 2013 and 2015), the World Cup winner in the season 2013/2014, the 65th winner in the Four Hills Tournament. In the Summer Grand Prix, he was twice classified second (in 2010 and 2011) and once as the third one (2016). The Summer Conti-











nental World Cup winner in the season 2010. The eight-time Poland's champion. The three-time Olympian. The best sportsman of Poland in 2014. He was awarded the Knight Cross of the Polish Revival and the Holmenkollen Medal. The winner of twenty seven medals in winter and summer Poland's championships – he won ten times. The latest Poland's record – the holder in the ski jump length (251.5 metres in team competition in Planica). His feature is a high aesthetics in body position during jumps and landing for which he scores high jury's marks, including the highest ones of "20". His personal best is 251.5 metres at Letalnica in Planica (25 March 2017).

Piotr Żyła – nickname: Wiewiór. He started to ski jump at the age of 8. In the World Cup, he made his debut on 1 January 2006 in Sapporo (19th place). His first victory in the World Cup on 17 March 2013 in Oslo. The individual bronze medallist in the Nordic Skiing World Cup in 2017, the team bronze medallist in 2017 and the bronze one in 2013 and 2015, the Olympian in Sochi in 2014. The second position in the 65th Four Hills Tournament. The tree-time individual Poland's champion (twice in the winter and once in the summer) and the winner of other eleven medals of the Poland's championship. His personal best is 245.5 metres which he achieved on 18 March 2017 at Vikersundbakken in Vikersund.





SIGNUM TEMPORIS 2017 SIGN OF THE TIMES Port Praski for the brave implementation of the innovative architectonic and urban project "The Port Praski - the city of a new generation", which will transform Warsaw into a modern capital of the 21st century

"The Port Praski - the city of a new generation" is a tremendous investment being implemented at harbour basins on the area of approximately forty hectares located in the very centre of Warsaw, close to the Old Town. Although developers like to use big words, everything seems to indicate that the Port Praski will really contribute to changing the image of the whole city. It is one of the largest architectonic projects in Europe of which implementation, due to the modern construction technology, has chances of matching the effects of the London Docs and due to the surrounding historic architecture -Venetia. The character of the Port Praski project stirs up more and more interest of inhabitants of Warsaw. It is recognised as one of the unique and few investments in Europe, of which image will contribute to the development and enrichment of the southern side of Warsaw, and it will also add variety to it.

Ultimately, the Port Praski will consist of four components: Stara Praga – the residential and shopping borough, the Docs – the luxury part with restaurants, exclusive boutiques and marina, the City – the shopping and office area and the Media Park – the media and technological part. In addition, the developer will construct flood defences which will protect the southern side of Warsaw, the subway station "National Stadium" at Sokola Street, the tunnel of the second subway

line from Targowa to Sokola and Wybrzeże Szczecińskie Streets, and also the adjacent area to Ratuszowa, Targowa and Francuska Streets. The project "The Port Praski – the city of new generation" was launched at the end of 2011; four residential and retail buildings have been already completed: Krowia 6, Sierakowskiego 5, Port and Latarnia. The whole investment is planned to be completed within the next years.

The Docs in the Warsaw Port Praski are intended to be not only the landmark of Warsaw in Europe but they are also planned to become the start point of water urban public transport. Due to becoming the beginning of the alternative for traffic-jammed streets, they are to become something more than the London Docs where water transport serves only tourist purposes.

Developing the urban river transport may turn out to be a very effective way of solving the traffic-jam problems, provided that it is not limited only to one port. It should be possible for inhabitants of Warsaw to reach various destinations, specifically in view of the fact that more and more people work and spend their leisure time in locations close to the Vistula River. The necessity of revitalising the queen of Polish rivers has already been discussed for a long time, and such investments as the Port Praski are happening before our very eyes.





the Song and Dance Ensemble of the University of Warsaw "Warszawianka" for unique achievements in promoting Polish traditions and culture

The song and dance ensemble of the University in Warsaw "Warszawianka" is the representative folk group composed of dancing, singing and playing students as well as graduates from almost all faculties of Warsaw University and other Warsaw universities as well. Lively Polish dances like polka, sztajerka and oberek are performed by students of physics, mathematics, computer sciences, law and administration, management and organisation, economics, history, Polish studies, philology, education, psychology, sociology, etc.

This year the Ensemble will celebrate the 45th anniversary. During all these years they performed in Poland and many countries all over the world. The number of concerts and countries they visited allow us to call the Ensemble the "Ambassador of Polish Culture". By following the saying "Education by folk" the Ensemble is one of the most active member of the Association the Polish Section of The International Council of Organizations of Folklore Festivals and Folk Arts (PS CIOFF). "Warszawianka" enraptures with beauty, youth, professionalism and colour gamut just like a kaleidoscope.

The artistic uniqueness of the Ensemble is composed of values accumulated through ages in the national culture to which folk art largely contributes. The style of "Warszawianka" consists in subtle stylisation maintaining values and qualities of prototypes. The same sources were used

by the greatest Polish artists such as Fryderyk Chopin, Karol Szymanowski, Henryk Wieniawski or Stanisław Moniuszko by stressing the essence of Polish identity.

Due to the decades-long hard work, the Ensemble acquired a very unique individual style and character. The repertoire of "Warszawianka" includes a wide range of programmes: national dances, images showing various regions of Poland – based on Polish customs and rites and educational performances and programmes for schoolchildren.

Concert activities include 52 foreign tours, over 1,000 concerts, full concert halls; the Ensemble participates also in the Polish Dances Tournaments – during seventeen editions of the Polish Championships, dancers of "*Warszawianka*" won 41 titles of the Poland's Champions, 27 titles of 1st Vice-Champions of Poland and 23 titles of the 2nd Vice-Champions of Poland.

Phonographic activity includes, among other things, albums released in recent years:

"Warszawianka in symphony" – album with the folk compositions performed by a symphonic orchestra;

"Spiewajcie i grajcie Mu...." (Sing and play for Him) – the double album showing the richness and beauty of Polish X-mas carols.

Apart from the concert and photographic activity, the ensemble is also engaged in educational, social and charitable activities.

Education: currently the Ensemble teaches 120



children and teenagers Polish dances and traditions. Within the framework of special economic programmes addressed to kindergartens and schools, dancers present Polish customs, and they teach children and young people about Polish national dances. The educational and charity programme addressed to young women at the age of 18-24 years of which culmination is the Debutants' Ball organised in the Museum of the Palace in Wilanów, is also very interesting. In the seventeen editions of the Polish Championships, dancers of "Warszawianka" won 41 titles of the Poland's Champions, 27 titles of the 1st Vice-Champions of Poland and 23 titles of the 2nd Vice-Champions of Poland.

Social activity consists in the participation in

the Nationwide Student Campaign "Cut a caper" having been organised since 2010 to promote the Polish folk culture by encouraging passers-by and tourists to dance together in the streets of cities. "Warszawianka" has taken part in this campaign since 2013, and it organises also educational concerts at seniors' centres.

Charity activity: the Ensemble has already for many years organised the Charity Campaign "Podaj Serce" (Give your heart) to raise awareness of problems of persons suffering from multiple sclerosis and acquire sponsors for them. The Ensemble members are actively involved in the campaign "Noble Parcel", and they also organise concerts "Students for children" addressed to children with special needs.

The Humming Bears [MyHummy] Polish: Szumisie are humming bears created for babies ensuring their restful sleep. They were designed by the team of caring parents who wanted to create the original and unique product ensuring a perfect comfort of sleep for all children. The white noise which they emit helps new-borns to calm down and fall asleep by recreating soothing sounds of their mothers' womb.

The concept of the humming bears arose over 7 years ago when the co-owner of the producer - Anna Skórzyńska, became a mother. Her son loved to fall asleep with the sound of a hair-dryer.

The white noise calmed him during colics and teething. During one of the sleepless nights, when sitting at her son's bed, she hit on the idea to put the hum of her dryer "inside" the soft teddy-bear which will be a safe companion of her child.

There was, however, a very long way to go from the idea to its implementation. The first version of the Humming Bear was created in 2014. The humming bears in their present form have been available on the market for two years. Initially, they were distributed only online, and at the end of 2015 – they reached shop shelves.

Currently, the Humming Bears are available in






over 200 shops throughout Poland. In the beginning of 2016, the firm commenced the export of its humming bears under the English name "my-Hummy" initially to Germany and then, to other European countries. Today the humming bears can also be found in France, Holland, Belgium, Switzerland, Denmark, the UK, Ireland, the Czech Republic, Slovakia, Slovenia, Estonia, Lithuania, Latvia, Iceland and also in Russia. Currently, over 70 percent of the firm's proceeds originate from export.

The humming bears can be found in hospitals throughout Poland, and they are recommended by doctors, midwives and psychologists. The firm was included in the prestigious list of 100 Innovators in the CEE region. It was also awarded the

10th place in the ranking of the "Most Creative Entities in Business" by Brief. The humming bears were also appointed by Google as the ambassador of the programme Internet Revolutions.

The humming bears are entirely manufactured in Poland from the approved materials safe for new-borns. The collection in the firm's offer includes a few shapes of the humming bears, special nursing pillows, blankets and sets of bedding. The latest achievement in the humming bears business are bears controlled remotely by the mobile application.

The humming bears lull over 100 thousand babies to sleep all over the world.



Jacek Stryczek – the Polish catholic priest, academic chaplain and the President of the SPRING Association.

He studied vibroacoustics at the University of Science and Technology in Cracow (AGH), from which he graduated 1988. In the years 1988–1993, he studied at the Papal Theological Academy. He was ordained to the priesthood on 15 May 1993. As from 1995 he was the academic chaplain, among other things, at the St. Anna Collegiate and Collegium Medicum at Jagiellonian University. In the years 1999–2007, he was vicar of the Divine Mercy parish in Prokocim Nowy. Since 2007 he has been the Businessmen Chaplain and the

Volunteers' Chaplain in the Małopolska province. He specialises in the Church PR and the business social responsibility.

In 2001, he was one of the founders of the SPRING Association engaged in such projects as "Noble Parcel" and "Academy of the Future".

Noble Parcel (until 2009 the **Christmas Parcel**) – a nationwide project of assisting families in difficult financial situation implemented by the SPRING Association. Parcels are delivered to such families two weeks before Christmas.





The campaign was organised for the first time in Cracow in 2000 when the group of academic pastoral care led by priest Jacek Stryczek (currently the President of the SPRING Association) gave gifts to 30 poor families. In the edition of 2013, within the framework of this campaign, 530.5 thousand donors provided parcels to 17,684 families (70,700 persons), and the total value of such aid amounted to PLN 33.1 million. One parcel was prepared on average by 30 persons.

The programme is based on donations from private donors who respond to the needs of the most deprived persons from local communities. These needs are identified by volunteers, and they are entered in the anonymous web-based database.

From this database, donors can chose any family they want to help. Each year around November, one can chose the family from the web-based database and prepare a parcel for them. The main principle of the Noble Parcel is to provide aid to those families who wish to change their situation.

In each region, the project is managed by the leader who coordinates the whole work of the team of volunteers. Families are covered by the project according to one of the categories: a sick/disabled child in the family, a large family, old age and loneliness, illness, disability in the family, misfortune, a single-parent, others.

In the Noble Parcel project, each and every in-



terested person may become the donor. Donors often group together to prepare a given parcel. They also encourage their friends, colleagues, associates, families, schoolchildren or students to do so. This campaign requires also the assistance of benefactors. The benefactor is a person who contributes financial resources to the Noble Parcel. By supporting this project on a regular basis one can join the club "Spring and Friends".

Apart from private donors, the campaign is also supported by various organisations and individuals. So far, the campaign was joined by Pope Francis, the Presidential Couple Andrzej and Agata Duda, Jerzy Dudek with the Real Madrid team, the sisters: Agnieszka and Urszula Radwańska, Anna and Robert Lewandowski, Jakub Błaszczykowski and Łukasz Piszczek, just to mention a few.










OLIWIA SZYDŁOWSKA

Within just a few months she has become a successful dancer dancing both solo and in duet. Oliwia sees her future in dancing. Her dream is to present her skills on the international scene and share her skills and knowledge with those who love dancing as she does.







ORCHESTRA OF THE HUTA GLASS TADEUSZA WRZEŚNIAKA

The Orchestra of the Tadeusz Wrześniak Glass Works was founded in March 2007. Its own and only patron is the owner of the glass works - Tadeusz Wrześniak winner of the prize ENTREPRENEUR MAGNUS 2016 OUTSTANDING ENTREPRENEUR awarded by European Business Club Poland. Ms Alicja Urbanowicz is the conductor.

The orchestra is a big-band, i.e. a big band composed of the rhythm section (percussion, piano, electric and bass guitar) and the wind section divided into three ones: the trumpet, trombone and saxophone sections. This is probably the first such a young big band in Poland with the average musician's age of 13 years. The youngest musician is only 8 years old. None of them attend music school. All of them acquire musical education at the orchestra by learning how to play musical instruments from scratch.

The orchestra has many achievements on its account – in their own province, Poland and Europe as well. They gave hundreds of concerts which include among other things:

- in 2009 and 2010, it was awarded first place in the Małopolska Competition of Brass Bands in Więcławice;
- in 2008, its performance added splendour to the 100th anniversary of a Greek orchestra in Scripero in Greece, and it also gave concerts on Corfu island;
- in 2009, it gave a concert for Pope Benedict XVI at St Peter's Square in Vatican;
- in 2010, it gave concerts in Winnica, Ukraine;
- in 2015, the orchestra performed on TVN show "Got Talent". Their performance swept away the audience and jury, and it was awarded a standing ovation and received "3 x YES". The jurors assessed the bank performance as the biggest surprise of the 8th edition of the show;
- in 2016, the Orchestra performed in France, at the festival "May the month of Europe";
- it added splendour many times to ceremonies of the gala awards for "Model Communities" throughout Poland;
- in 2016, the Orchestra received the "Stambułka Staszowska" award for managerial and social activity carried out in compliance with statutory goals of the Staszowska Chamber of Commerce;
- on 4 October 2016, as the only orchestra in the whole history of the European Union it gave a concert for politicians from the whole Europe at the European Parliament in Strasburg;
- on 30 March 2017, it added splendour to the meeting of President Andrzej Duda with Staszów's inhabitants.
- on 1 May 2017, they played at the European Business Club Poland Picnic in the Royal Łazienki Park in Warsaw on the occasion of the 13th anniversary of Poland's accession to the European Union;
- on 12 October 2017, the Orchestra received the Świętokrzyska Culture Award for achievements enriching the cultural heritage of the Świętokrzyskie province.

Monika Urbanowicz – the winner of the 2nd edition of the TVN show "Mali Giganci" (Little Giants) and finalist of the national preliminaries of the Eurovision Song Contest Junior 2017 sang with the Orchestra and Mikołaj Bielaska – guitarist and bassist. During the concert, the orchestra played pop and film movie standards.

The 7th edition "Professionals for professionals" is composed of regular meetings held by entrepreneurs of the furniture industry organised by TopSolution with partners offering opportunities of attending free trainings, discussion panels and meetings with experts in various related areas of business.
